It is hereby notified to all the concern that, the standing committee of the Academic Senate vide letter No. 314/Acad.- I/2025, dated: 26.03.2025 & 483/Acad-I/2025 dated. 12-05-2025, has resolved to permit the B.E (**Non CBCS**) I Year, II/I, II/II, III/II, IV/I Sem. & Bridge Course (Backlogs); (**CBCS**) I, II, III, IV, V, VI, VII Sem. & Bridge Course (Backlogs) and (**AICTE**) I, II, III, IV, V, VI, VII Sem & Bridge Course I & II Sem (Backlogs) students to appear for their backlog papers, even after the stipulated period as a **One Time Chance**.

Hence, **BE** (Non-CBCS) students who have admitted from academic year 2000-2001 to 2014-15 in First year, **B.E Lateral entry students** admitted directly into 2nd year during the academic years 2001-02 to 2015-16 and **BE** (CBCS) students who have admitted in academic year 2016-17 in First year , **BE** Lateral entry students admitted directly into 2nd year during the academic year 2017-18 , Also **BE** students who have admitted in academic year 2018-19 in First year , **BE Lateral entry students** admitted directly into 2nd year during the academic year 2019-20 are eligible to appear in the ensuing examination, with a penal charges per paper, in addition to the normal examination fee, as a **One Time Chance**, with the existing syllabus/scheme.

The examinations will be conducted in the month of July 2025. The detailed time table will be issued in due course. This notification is meant for backlog candidates only. Fee once paid will not be refunded or adjusted.
