
Welcome Address: The meeting commenced at 11:00 A.M. with a warm welcome by Prof. M. S. Rawat, Principal, and Chairman Academic Council, MJCET (A), who extended his greetings to all Academic Council members.

Address by Member Secretary, Academic Council, MJCET(A): Prof. Mohammed Hamraj presented the agenda of the Academic Council and requested the Academic Council members to deliberate and provide their valuable suggestions and recommendations for the enrichment of academic policies, schemes and procedures, and sought approval for the same.

Presentation by Controller of Examinations, MJCET(A): Prof. Syed Ferhatullah Hussainy gave a brief presentation on the Autonomous Rules and Regulations that will be adhered to by MJCET after obtaining autonomy. He elaborated on the equivalent framework, examination system alignment, and moderation procedures to ensure compliance with norms while maintaining academic flexibility.

Presentations by Chairpersons of Boards of Studies (Heads of Departments): The Chairpersons of the Boards of Studies presented detailed proposals for their Schemes and Syllabi (duly approved by respective Boards of Studies) for I and II Semesters, followed by Schemes of III semester to VIII semester for the kind consideration and approval of the Academic Council.

The schemes and syllabi presented in the following order:

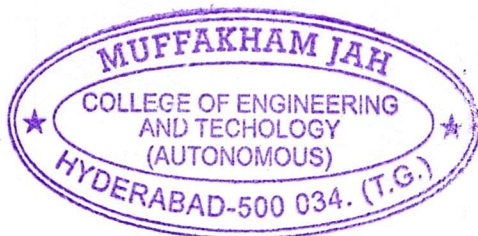
- Civil Engineering – B.E. Civil Engineering, M.E. Structural Engineering
- Computer Science and Engineering: B.E. CSE and M.Tech. CSE
- Computer Science and Artificial Intelligence (Allied): B.E. CSE(AI), B.E. CSE(AI & ML), and B.E. CSE (DS).
- Electronics and Communication Engineering: B.E. ECE and M.E. Embedded Systems and VLSI Design
- Mechanical Engineering: B.E. Mechanical Engineering and M.E. CAD/CAM

Each department's presentation covered:

- Stream-wise adherence to AICTE Model Curriculum and Semester-wise distribution of total credits
- Scheme of Instructions & Examinations for Semesters I and II of BE Courses
- Scheme of Instructions & Examinations for Semesters III to VIII Semesters of BE Courses
- Scheme of Instructions & Examinations for ME Courses

Suggestions and Recommendations:

- It was recommended to adapt division of CIE and SEE marks for M.E programmes as CIE 40 instead of 30 and 60 instead of 70 to maintain uniformity with UG programmes.
- Rules and guidelines be framed for students who fail to secure minimum required marks in case of Medical Emergency cases.
- Re-admission policy be framed for detained candidates who fail to secure minimum 25% credit.
- In place of "Mathematics III" in BE Civil Engineering Scheme, it was suggested to write the Subject Name.
- Summer Internship course credits be written/mentioned in VII semester for evaluation of Internship carried out during VI semester Summer break.
- It was suggested to keep AICTE credits split in the scheme against the B.E. CSE scheme offered by department.
- It was suggested to maintain uniformity in allotting credits for Summer Internships across all branches of UG courses.
- It was suggested to mention the prerequisites be defined for professional elective courses.
- Policy document to be framed for MOOCs/NPTEL courses and these courses are to be encouraged during III to VII semester. The due approval of BoS be taken.
- The professional elective "Intellectual Property Rights" in CS & AI (Allied) courses to be offered under Humanities category, and to be listed as an audit course.
- Avoid the core subjects in VIII semesters of scheme, instead electives are recommended

- Community Services course in B.E. Mechanical Engineering be allotted one credit and must have internal evaluation to ensure participation.
- For B.E. Mechanical Engineering scheme, it was recommended that the Industrial Visit need not be mentioned in scheme otherwise an evaluation has to be conducted for the same.
- For summer internship the duration of 4 weeks be mentioned in scheme. Also suggested to remove the contact hours from scheme.

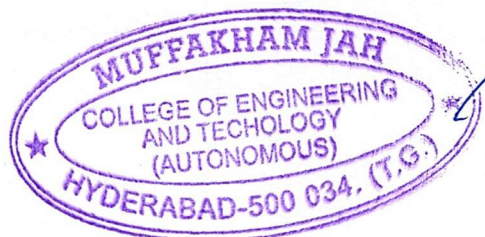
After thorough deliberation and discussions, the Member Secretary, Academic Council requested for the kind approval of the following by the Academic Council:

Resolutions Passed:

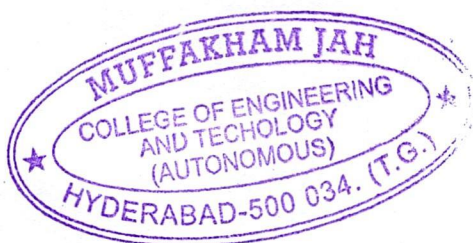
1. The proposed Schemes and Syllabi of all departments were approved by the Academic Council.
2. The Academic Regulations and Evaluation Procedures were approved for implementation from the Academic Year 2025–26.


