The agreement will basically cover

- Exchange of faculty/staff members;
- Exchange of students maximum of five students each way annually;
- Informing students about English taught Master programs;
- Co-ordination in joint projects, seminars, conferences, etc.;
- Other activities based on the agreement between the two institutions/parties.

Expenses incurred from participation in the exchange program will be borne by the sending side or the participating individuals. This agreement is effective upon signing of the agreement by both parties and shall be in effect for five years. Revision and modification may be done by mutual consent in writing. Renewal of this agreement requires discussion and mutual consent by both parties prior to the expiration date. Either party may request an early termination of this agreement by written notification to the other party at least six months in advance of the desired termination date.
